# Important Trash & Recycling Updates

On July 1, 2023, the City will transition over to a new trash collection company. The new trash company we are working with is Legacy Disposal Solutions, formally known as RAK Sanitation. Legacy Disposal will be doing both curbside trash and curbside recycling. We will send out a separate email when we have a date when WastePro cans will be picked up. The new trash company, Legacy Disposal, will drop off new cans, 1 recycle and 1 trash, at your home the last 2 weeks of June. If you do not have your new bins by the end of June and/or your WastePro bin(s) are not picked up, please contact City Hall so we can get them picked up/delivered to your home.

If you already have back-door pick-up or a second trash can, that service will still be provided to you as before. You are able to get an additional trash can from Legacy Disposal Services for an additional cost of \$12.50 a month. If you need an additional can, please email [utilitybilling@mountainparkgov.com](mailto:utilitybilling@mountainparkgov.com) to request an additional bin.

**Our new trash and pick-up day will be Fridays with the first pick-up day being June 30<sup>th</sup>.** Please put your Legacy Disposal issued trash bin(s) out Thursday evening after 6pm or by 6am Friday morning so it can be collected. If your trash bin is not emptied by the end of the day on Friday each week, please email City Hall at [utilitybilling@mountainparkgov.com](mailto:utilitybilling@mountainparkgov.com) by Monday morning at 9am so we can let Legacy Disposal know to pick it up on Monday afternoon. We ask that you bring your trash bin in from the road by Saturday morning, unless your trash was missed.


Items allowed in recycling bins are printed on the recycling can should you have questions on what is allowed. #1 plastics, paper, and cardboard ARE allowed, but they must be cleaned and free of food/trash. Legacy Disposal WILL NOT put any contaminated recycle bins in the recycle truck.

We will no longer have our monthly bulk dumpster day at the pool. Instead, we will have a dumpster at the pool 2 times a year and the weekend that it is there will be announced in the monthly newsletter and on the City website. Legacy Sanitation does offer curbside bulk pick-up for a price that will be billed directly to the homeowner. # MPVFR NEWS



## MEET *First Responder*, Lt. Michael Peck

### MPVFR VOLUNTEER AND CODE ENFORCEMENT OFFICER FOR THE CITY OF MOUNTAIN PARK



According to Lt. Michael Peck, Mountain Park is “The best kept secret in Georgia. No visible commercial business. No brick and mortar. A wildlife refuge not ruined by retail.” Lt. Peck is passionate about public safety and joined the Mountain Park Volunteer Fire & Rescue in 2017 to “fulfill his childhood dream of becoming a Firefighter”. He searched for just the right-sized department and chose Mountain Park because “It is a small, tight knit community. Whether you love your neighbor or you don’t, you look out for them, because what affects them affects you.” The compassion and family-like environment of this close-knit city

reminds Michael of the small community where he spent his youth in Montgomery, AL and wants to do his part to ensure both the safety and progression of our city.

Lt. Peck became the city’s Code Enforcement Officer in October 2022. The city of Mountain Park is fortunate to have this well trained and dedicated man serving us as an MPVFR volunteer and as the city Code Enforcement Officer.

While serving in the Marines, Michael attended Alabama State University studying Theatre and Criminal Justice. He has served in the justice system for 18 years. First as a DeKalb County Police Officer for eight years, where he was assigned to North Precinct and eventually the Special Operations’ Tactical Response Team/Mobile Field Force. He went on to work at DeKalb Medical in Security and Emergency Management. In 2016 he accepted a position at Children’s Hospital Atlanta in Security as a Special Investigator, a supervisor, and departmental Instructor and currently works in Campus Safety at Oglethorpe University. He is considering working part-time in the city with the Fulton County Sheriff’s Department as well. If that works out, he says, “he is just as happy and eager to do it unpaid, in the same manner as he is working with the Fire and Rescue Department, as a Reserve Deputy.”

Michael has three boys and works hard for them. “My parents taught me how to be a great parent, but my boys make me an *amazing* one. They are my reason for everything,” He says. Lt. Peck has Emergency Medical Responder (EMR) training in the past. He has been first to arrive at medical emergencies and lift assist calls in Mountain Park. He completed his Volunteer Firefighter with Live Fire training in 2018. He is currently assisting Chief Miceli with recruiting new volunteers; in addition to the 15 volunteers on staff, there are new volunteers coming on board. He adds that MPVFR now has three certified in-house instructors, so instruction doesn’t cost the city a dime. Recruits have been completing courses in Basic Life Support (BLS) and are now moving on to Firefighter I training. Classes are held every Thursday night at the station. COVID severely affected MPVFR staffing. Michael himself contracted COVID *three*

times and pneumonia *right after*. With the addition of new recruits and certified trainers on staff, MPVFR is bouncing back better than ever.

Michael states, “When God tells you to do something, you do it. I may not be a resident of Mountain Park, but I am willing to do anything I can to help this beautiful city.”

In addition to Fire and Emergency medical calls, MPVFR assists with other emergencies like down power lines, fallen trees, etc. On May 28th, a tree fell blocking Hemlock Street – residents could not get in or out. Lt. Peck and our one and only maintenance worker, George Owens, came to the rescue! The tree was cleared in less than an hour.





# Know Your City Code



## LITTERING

Mountain Park is unique for its wooded beauty and surrounding lakes. In order to keep our community's beauty the City of Mountain Park staff would like to remind you that it is unlawful for any person or persons to dump, deposit, throw, leave, cause or permit the dumping, depositing, placing, throwing or leaving of litter on any public or private property in this city or any waters in this city. The litter and debris, including yard clippings, ends up in our streams and lakes. Please help keep our city clean!

### **Sec. 105-365. - Prohibition against littering public or private property or waters.**

- (a) It shall be unlawful for any person or persons to dump, deposit, throw or leave or to cause or permit the dumping, depositing, placing, throwing or leaving of litter on any public or private property in this city or any waters in this city unless:
- (1) The property is designated by the state or by any of its agencies or political subdivisions for the disposal of such litter, and such person is authorized by the proper public authority to use such property;
  - (2) The litter is placed into a receptacle or container installed on such property; or,
  - (3) The person is the owner or tenant in lawful possession of such property, or has first obtained consent of the owner or tenant in lawful possession, or unless the act is done under the personal direction of the owner or tenant, all in a manner consistent with the public welfare and all other applicable laws and ordinances.
- (b) Notwithstanding paragraph (a), when such property or waters is a construction site, construction site operators must control waste such as discarded building materials, concrete truck washout, chemicals, litter, and sanitary waste at the construction site that may cause adverse impacts to water quality. "Control waste" means to properly contain and dispose of waste. Loose construction debris (e.g., packing materials, scraps of lumber, etc.) shall be promptly contained and removed from the site and properly disposed of.



### **Sec. 105-366. - Vehicle loads causing litter.**

No person shall operate any motor vehicle with a load on or in such vehicle unless the load on or in such vehicle is adequately secured to prevent the dropping or shifting of materials from such load onto the roadway. This shall require at a minimum covering any waste load with a tarp.

### **Sec. 105-369. - Penalties.**

Any person who violates this article shall be guilty of a violation and, upon conviction thereof, shall be punished as follows:

- (1) By a fine of not less than \$200.00 and not more than \$1,000.00; and
- (2) In addition to the fine set out in subsection (1) above, the violator shall reimburse the city for the reasonable cost of removing the litter when the litter is or is ordered removed by the city; and
- (3) a. In the sound discretion of the court, the person may be directed to pick up and remove from any public street or highway or public right-of way for a distance not to exceed one mile any litter he has deposited and any and all litter deposited thereon by anyone else prior to the date of execution of sentence; or  
b. In the sound discretion of the court, the person may be directed to pick up and remove any and all litter from any public property, private right-of-way, or with prior permission of the legal owner or tenant in lawful possession of such property, any private property upon which it can be established by competent evidence that he has deposited litter. Pick up and removal shall include any and all litter deposited thereon by anyone prior to the date of execution of sentence; and,
- (4) The court may cause to be published, at the convicted violator's expense, the names of persons convicted of violating this article.

**June 3rd**.....**FINAL** monthly Dumpster Day 7am-10am

1. Must provide proof of residence in the City of Mountain Park.
2. ONE TRUCKLOAD OR TRAILER LOAD PER RESIDENCE.
3. All yard debris must be cut into 3 feet sections or less.

*Please note that this is a service provided by Waste Pro as a courtesy and the City of Mountain Park does not have any control over what time they arrive/depart or the rate which the dumpster fills and the amount it can hold. Please plan accordingly. Thank you!*
