CALL 911!

An emergency is any situation that requires immediate assistance from the police, fire department or ambulance. Examples include:

- A fire
- A crime, especially if in progress
- A car crash, especially if someone is injured
- A medical emergency, especially for symptoms that require immediate medical attention

When you call 911, be prepared to answer questions, which may include:

- The location of the emergency, including the street address (Tell them the "City of Mountain Park")
- The phone number you are calling from
- The nature of the emergency

Wireless E911 Calls


Wireless 911 rules aim to provide 911 call centers with meaningful, accurate location information so that local emergency responders can be dispatched quickly to help wireless 911 callers.

However, even in 2021, when you call 911 from a mobile phone, your mobile provider may route calls to a regional center, based on a tower location and whether it can determine your location.

In other words, a E911 Operator in a different city or county may answer.

Once they have the information, then the E911 Operator can transfer you to the correct center.









Option 1 – Dissolve MPVFR & continue w/ Roswell Agreement Only

- Pro: 24/7 Coverage
- Con: No Good Cause Response
- Con: Anticipated Longer Response Times
- Con: Higher Annualized Cost based on current Agreement (Future Costs Uncertain)

Option 2 – Continue w/ Roswell Agreement & Recruit MPVFR

- Pro: Training our own force
- Pro: Good Cause Response
- Pro: Shorter Response Time
- Pro: Potential for renewed IGA
- Con: Cost of both Roswell and MVFPR for at least 18 mo
- Con: MPVFR not fully or 60% staffed for at least 12+ mo

Option 3 – MPVFR is EMS Services Only

- Pro: Answers Majority of Call
- Pro/Con: Roswell is still contracted for Fire and unstaffed times
- Pro: Reduce cost of Equipment and Training
- Con: Not staffed for Fire and Longer Response times for Fire
- Con: MPVFR not fully or 60% staffed for at least 12+ mo
